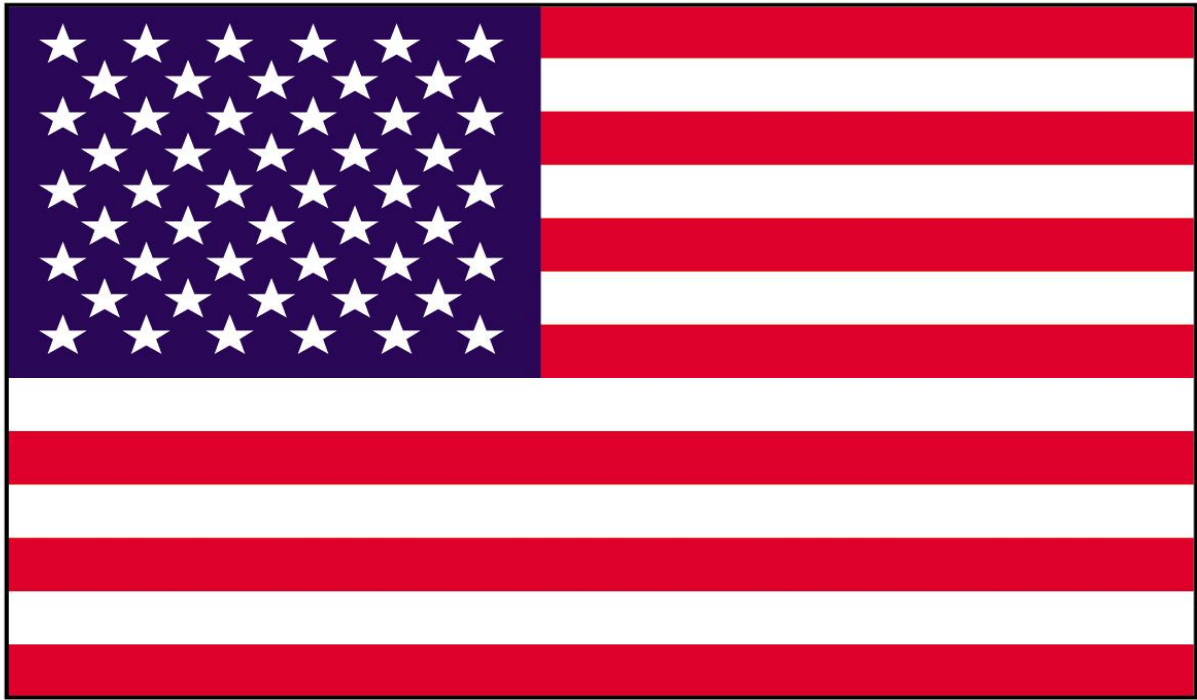
This is the 68th year of the Marshall County Fair. Community involvement and support is essential for the Fair to continue operating from year to year.

INFORMATION AND GENERAL RULES

1. The Fair will open at 6:00pm, Tuesday, September XX, 2026 and will close at 11:59pm, Saturday, September XX, 2026. All times and dates are subject to change.

2. Where any conflict appears between these general rules and the special rules governing the different departments, our special rule will take precedence. The Marshall County Fair Board reserves the right to construe its own rules and regulations and to determine all matters and differences in regard thereto including amendments.

3. The Marshall County Fair Board ensures the buildings are secure each night. While every reasonable precaution will be taken for safe-guarding exhibits, it should be understood that the exhibits are entered into competition for prizes, and the owner assumes all responsibility for any accident, loss or damage that may occur. Neither the Marshall County Fair Board, its officers nor agents will be responsible for any such accident or damage.

4. **Competition is open to the general public.**

5. Individual and Booth entries can be entered on September X-X, 2026, from 9:00am until 5:00pm. The size of all booths will be **8'x8' and limited to 35 total**. Indoor booths are on a first come first serve basis. **The entry fee for individuals, civic groups, non-profit organizations and church exhibits with indoor booths for the 2026 Fair are free.** Commercial/businesses entities which display tractors, agricultural equipment items will not be charged a fee and can display up to 5 pieces of equipment. These agricultural displays will not be judged and are for education and business promotion only. Private business entities who want to sell items at indoor exhibits will be charged a fee established by the Directors. All entries close on Saturday, September X, 2026, at 5:00pm, unless otherwise specified in department rules or by agreement of the Fair Manager. All entries must be made on the regular entry blank furnished by this Board. Baked goods and flowers can be brought in on Sunday morning, September X, 2026, **with permission from the Fair Manager.**

6. All exhibits entered for competition shall be subject to the control of the Department in which they are exhibited.

7. The Marshall County Fair Board does everything it can to protect exhibits, **but in no case will it be responsible for loss or damage that may occur to them.**

8. Except as otherwise provided for by special rules governing certain Departments, all exhibits **must** be in place and fully installed by 5:00pm, Saturday, September X, 2026. With permission from the Fair Manager, cooked food and live flowers can be brought in on Sunday, September X, 2026.

9. All booths will be **8'x8'**. Limited outside booth space will be available. **The entry fee for commercial and political candidate booths is waived for the Marshall County Fair 2026, with the exception of exterior commercial displays outlined in Rule 5 above.** Any exhibitor having a space reserved and not occupying same or making preparation to occupy it 24 hours prior to the opening date of the Fair should be aware the reservation may be cancelled at the discretion of the Marshall County Fair Board.

10. Indoor Booths/Exhibitor Booths with electricity – Indoor Booths/Exhibitors will not share electrical hookups with other exhibitors or booths.

11. For every article entered, the exhibitor will be given a duplicate copy of the entry blank showing exhibitor's name, department, and class number of each article. This receipt must be preserved and presented at the close of the Fair when each article is called for and claimed.

12. Exhibitors will be held responsible for the cleanliness of their exhibits and space surrounding same. All exhibits must be in complete order each day at least thirty (30) minutes before the opening hour. No work on an exhibit or booth will be permitted during the hours the buildings are open to the public. In case of failure on the part of exhibitors to observe this rule, the Fair Manager may adopt such means to enforce the same as circumstances may suggest.

13. When space is allotted, a permit to occupy will be given. Such permit will not be transferred, and no other party will be allowed to share such place with the original applicant.

14. Advertising matters and sample of articles in a commercial exhibit booth or political candidate booth may only be given to the public from booth space or exhibit. The right is reserved to restrict or discontinue this privilege whenever it is carried to excess or becomes an annoyance to visitors. These booths, advertising matters or samples cannot be shared by another.

15. Advertising by means of posters, business cards, handbills, samples, etc. will not be permitted within the Fairgrounds except upon agreement with the Fair Manager.

16. All articles, after being entered and surrendered by the owner or agent will be entirely the control and jurisdiction of the Marshall County Fair Board. No exhibitor will be allowed to remove, handle, rearrange, improve or disfigure same under any circumstances.

17. Department Director or member of the Fair Board of Directors may enter exhibits for prizes in competition with the public.

18. If it is ascertained that any exhibitor, in an unprofessional manner, refuses to comply with the regulations of the Marshall County Fair Board, as indicated by the officers, and has taken exceptions to the judgment of a judge or an awarding committee, the Board of Directors shall bar the person so offending from competition for a premium or exhibiting on the grounds of the Marshall County Fair Board until they have made proper amends and have been reinstated by a vote of majority of the Board of Directors.

19. An exhibitor who tears off a premium ribbon or authorizes any person to do so in the presence of the awarding Judge, or who refuses to accept a ribbon from a Judge or otherwise insults the awarding Judge, shall forfeit the premium and/or ribbon and will be excluded from competition.

20. If it is ascertained that an exhibitor has made or caused to be made a false statement regarding any animal or article exhibited, or if any exhibitor shall attempt to interfere with the judges in their performances of their duties, they shall be excluded from competing or from exhibition on the grounds of the Marshall County Fair Board.

21. No smoking, lighted candles, lamps, matches, etc. will be allowed in any stables, stalls or exhibition booths on the grounds or buildings.

22. The Fair Manager reserves the right to decline any exhibit or exhibits.

23. **The Marshall County Fair Board Management, Jimmy Harris VFW Post 6837, nor Jimmy Harris VFW Auxiliary 6837 will be responsible for accidents on the Midway.**

24. **No alcoholic beverages are allowed on premises of the Fairgrounds or the perimeter.**

REMOVAL OF EXHIBITS

No exhibit shall be removed in whole or in part during the period of the Fair except with the permission of the Fair Manager. The building will be open Sunday following the Fair for removal of exhibits from 1:00pm until 5:00 pm on September XX, 2026. **All premiums will be paid by cash on September XX, 2026 when the exhibits are picked up by the owners.**

ENTRIES

1. Application for booth space for Club Exhibits should be made to the Fair Manager as soon as possible to ensure a space. Applications can be picked up at Jimmy Harris VFW Post 6837 or call 256-593-9470 and leave a message if no one answers. Also, applications are posted at vfw6837.org website, under "Announcement." **Fair Board email address is: Cfe@vfw6837.org**

2. The Director of each Department must check the entries shown by the Entry Books in each division with the exhibits presented and so mark the Entry Books they will show articles that were passed on by the Judges.

3. No invention or product from a convict or prisoner will be received for premium competition.

4. For information governing entries for each Department, see special rules under Department headings.

5. All entries must have been made or produced since September 2024. Commercial manufactured or produced articles will not be accepted. Articles having won premium at previous Marshall County Fairs cannot be accepted. All work must be original and entered by the individual that created it.

AWARDS

(NOTE CAREFULLY ALL AWARDS RULES)

1. A \$200.00 LIMIT ON ANY PERSON OR ADDRESS WILL BE MAXIMUM PRIZE MONEY AWARDED FOR INDIVIDUAL EXHIBITS OR GROUPS. A LIMIT OF 50 ITEMS PER ADDRESS IS ENFORCED.

2. IN THE EVENT OF CIRCUMSTANCES BEYOND OUR CONTROL, SO NOT TO DISRUPT OUR SCHEDULES AS TO NECESSITATE CURTAILMENT OF ACTIVITIES AND OPERATIONS, THE FAIR BOARD RESERVES THE RIGHT AND THE EXHIBITOR AGREES TO PRO-RATE PREMIUM AND PRIZE MONEY HEREIN CATALOGUES ON BASIS OF FACTUAL CONDITIONS EXISTING FROM SUCH CAUSES DURING THE PERIOD OF THE FAIR.

3. Exhibits are judged by comparison and on competitive basis. Where there is but one article exhibited under any section. A first prize award cannot be given. In this instance, if the article is meritorious, second prize premium will be paid, and second prize ribbon awarded. Prize money and ribbon will be awarded for first and second place and a ribbon awarded for third place. No premium or ribbon will be awarded when the exhibit is unworthy though there be competition. In the awarding of all premiums and ribbons, quality is the first consideration.

4. Premiums will not be paid according to ribbons, but by awards shown in the Judges' record book, for ribbons do not always mean money prizes and may sometimes be attached through mistakes or may be misplaced or lost. **The Judges' record is the only guide for paying cash awards. All premiums will be paid by cash on September XX, 2026 when the exhibits are picked up by the owners.**

SELLING EXHIBITS

1. Individual exhibitors have the privilege of selling anything they have on display for delivery at the close of the Fair or to take orders for delivery.

2. Delivery at the time of sale may be approved by Fair Manager.

JUDGES

(JUDGING WILL BE ON SUNDAY, SEPTEMBER X, 2026 ONLY)

1. Should any doubt arise about the regularity of an entry or any other important matter which the Judge feels incompetent to decide, they shall at once report same to the Fair Manager.

2. No one will be allowed to act as Judge, in a Department in which they have exhibits.

3. All Judges will be selected for their known familiarity with the classes on which they are invited to award premiums and are instructed that if they shall have good reasons to believe that any exhibitor, by false entry or otherwise, attempts to deceive the Judges or the public and obtain a premium by misrepresentation they shall report the fact at once to the Fair Manager who shall report the matter at once to the Board of Directors for action.

4. The decisions of awarding Judges shall be final, and no appeal shall be considered except in case of protest.

5. Objections to any person serving as a Judge must be submitted to the Fair Manager in writing, prior to making award, giving good sufficient reasons for the objections.

6. Any exhibitor attempting to interfere with the Judges during adjudications will be promptly excluded from competition.

7. The Judges will award prizes on the articles regularly mentioned in the premium list and may award ribbons on such articles not mentioned in the premium list if they consider them worthy.

8. There will be no one present at time of judging except the Official Judges and one Fair Official who will act as secretary only.

PROTESTS

1. Protest against an award must be made in writing accompanied by affidavits which must specify in full the grounds for protest, and a deposit of \$100.00 to the Fair Manager before the close of the day following the making of such an award. In case the protest is not sustained, the deposit shall be forfeited to the Marshall County Fair Board.

2. The Fair Manager will notify the exhibitor of the protested exhibit of such protest and both parties will then have 24 hours to bring sworn testimony in the case to be submitted to the Board of Directors. The protested award will be held in abeyance until the final action of the Board of Directors passing on same.

PUBLIC CONVENIENCES

During the Fair, the grounds will be equipped with every convenience for public comfort including restrooms and information bureau.

DEPARTMENT 1 – GROUPED

1. All clubs/groups desiring to enter exhibits contact Fair Manager at 256-593-9470; if there is no answer please leave a message. Also, you can email the Fair Manager at Cfe@vfw6837.org.
2. All clubs/groups desiring to make an exhibit must make application for space on or before **Friday, August XX, 2026**.
3. **Prize money will be paid by cash on September XX, 2026, when the exhibits are picked up by an authorized Representative of the organization.**

SECTION A - COMMUNITY EXHIBITS

The Marshall County Fair Board offers cash prizes on collective community organizations to be exhibited at the Fair under the following conditions. The general rules and regulations should also be reviewed.

1. These exhibits are to represent the activities of community life, embracing exhibits from the home, the farm, the garden, the school, school clubs, and the shop. Also, other projects of the community such as club activities, church activities, youth clubs and activities, etc.
2. The exhibits may be sponsored by community clubs, church groups, and other organized community clubs (**only one community exhibit per community is permitted**). In case one or more groups desire to exhibit, the said groups must decide among themselves as to who will be the exhibitor.
3. Products shown in exhibit must be superior in quality and attractively displayed.
4. The cost of material and labor incident to the complete display is to be borne by the organizations entering the display.
5. All such community displays shall be made and exhibited in a space 8 feet long and 8 feet deep in the exhibit building. Said exhibit and display to be erected, arranged and decorated without outside professional assistance. The exhibit should follow the plan of showing the resources of community, together with practical educational features portraying community and home life, rural or urban.

When there is no competition, second prize will be given if merited. The following scorecard is to be used in judging these exhibits.

SECTION B – FUTURE FARMERS OF AMERICA (FFA)

1. Open to High Schools in Marshall County only. The FFA Booths are to be put on by schools featuring the work taught in the FFA.
2. Exhibits will be made to display field, orchard, garden, animal product, mechanics, carpentry, etc.
3. Articles on display are to have been produced by the Students in the schools.
4. Exhibits should have strong educational points. The practices presented in the exhibit are to be educationally sound and easily understood by the observer.

SECTION C–Family, Career and Community Leaders of America (FCCLA)

1. Open to all High Schools in Marshall County only. The FCCLA booths are to be put on schools featuring the curriculum taught in the Family, Career, and Community Leaders of America classes.
2. The exhibit should present one main idea clearly expressed with all parts related to the central theme.
3. The central theme of the exhibit should be distinctive, meaningful and appropriate to the fields of family, career, and community leadership.
4. The practices presented in the exhibit are to be educationally sound and easily understood by the observer.
5. The exhibit should show opportunities for worthwhile learning experiences for present and future FCCLA students.

SECTION D – 4-H CLUBS

1. Exhibits are to be only by Marshall County 4-H Clubs.
2. Exhibits should have strong educational points.
3. Exhibits are to display fields, orchards, garden, animal products, domestic arts and/or hand crafts.
4. Articles in the exhibit must be made or produced in Marshall County.

2. Competition is for market goats. All breeds and crossbreeds of goats are eligible for competition.
3. Exhibitors must show their own animal in each class unless an exhibitor has more than one animal in that class. Another properly entered goat exhibitor, with animals at the show, must exhibit the others' entry.
4. No goat exhibitor can receive unauthorized help in the show ring.

5. All animals will be exhibited at the owner's risk. Feed and care must be provided by the owner.
6. Animals are to be shown in their natural conformation.
7. Wethers and does, of any breed or crossbreed, with milk teeth in place, weighing 35 pounds or more, are eligible to compete.
8. No active breeding Billys are allowed.
9. Any properly entered youth meat goat exhibitor is eligible to enter showmanship. Exhibitor's showmanship class is determined by age of exhibitor on the date of the show.
- 10 The Marshall County Fair Board reserves the right to make changes if necessary.
11. Each exhibitor may show a maximum of four (4) goats.

3. Entries are open to youth that are from Marshall County or bordering counties. They must be 5 years old by **September 1, 2026** and not more than one year out of High School. The exhibitor must be physically capable of showing and controlling their animal in each class entered.
4. All entries must have their milk teeth. Lambs should be born after **January 1, 2026**. Any lamb that has lost the center pair of temporary teeth is classified as a yearling and will not be eligible to show.
5. All lamb entries must weigh a minimum of 75 pounds.
6. Each exhibitor may show a maximum of four (4) lambs.
7. Lambs must have their tails docked and should be shown in short fleece.

8. The showmanship contest shall consist of four (4) divisions based on the age of the exhibitor as of the date of the show.

9. Each contestant in the showmanship contest must show his/her own lamb.

10. The Marshall County Fair Board reserves the right to make changes, if necessary.

11. Feed and care must be furnished by the exhibitor.

12. Entries must be wether or ewe lambs.

13. The lambs will be divided into weight classes.

14. There will be Lightweight Classes, Middleweight Classes and Heavyweight Classes.

4. Exhibitors must show their own animal in each class.

5. No exhibitor can receive unauthorized help in the show ring.

6. All animals will be exhibited at the owner's risk. Feed and care must be provided by the owner. Where there is no competition in a class, second place prize money will be given.

7. To be eligible to compete for premiums, all animals must be halter broken and well groomed. Exhibitor's showmanship class is determined by age of exhibitor on date of show.

8. The Marshall County Fair Board reserves the right to make changes if necessary.

HEALTH REGULATIONS

1. General: All cattle exhibited must appear in healthy condition. An official health certificate signed by an accredited veterinarian is not required.

2. Brucellosis Regulations: No test required on calves under 6 months of age. No test required on officially calf hood vaccinated animals under 24 months.

3. No test required on Alabama cattle if they originate from a herd that is not under quarantine because of brucellosis.

4. Tuberculosis Requirements: No TB test required

6. All swine will be permitted to leave after completion of the show.

8. All entries in the Market Hog Show are required to have a readable ear tag.

9. Show committee will determine showmanship classes depending upon participation.
